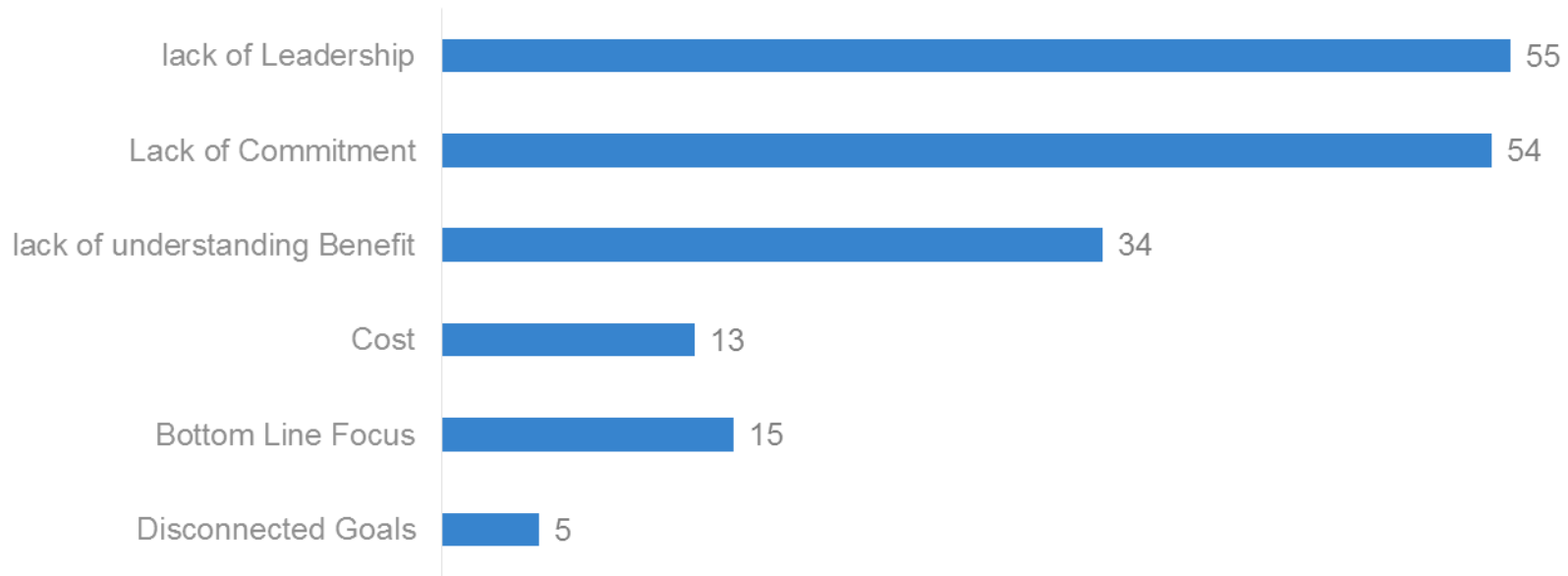

Why do you do you think some Organisations fail to manage Health & Safety?



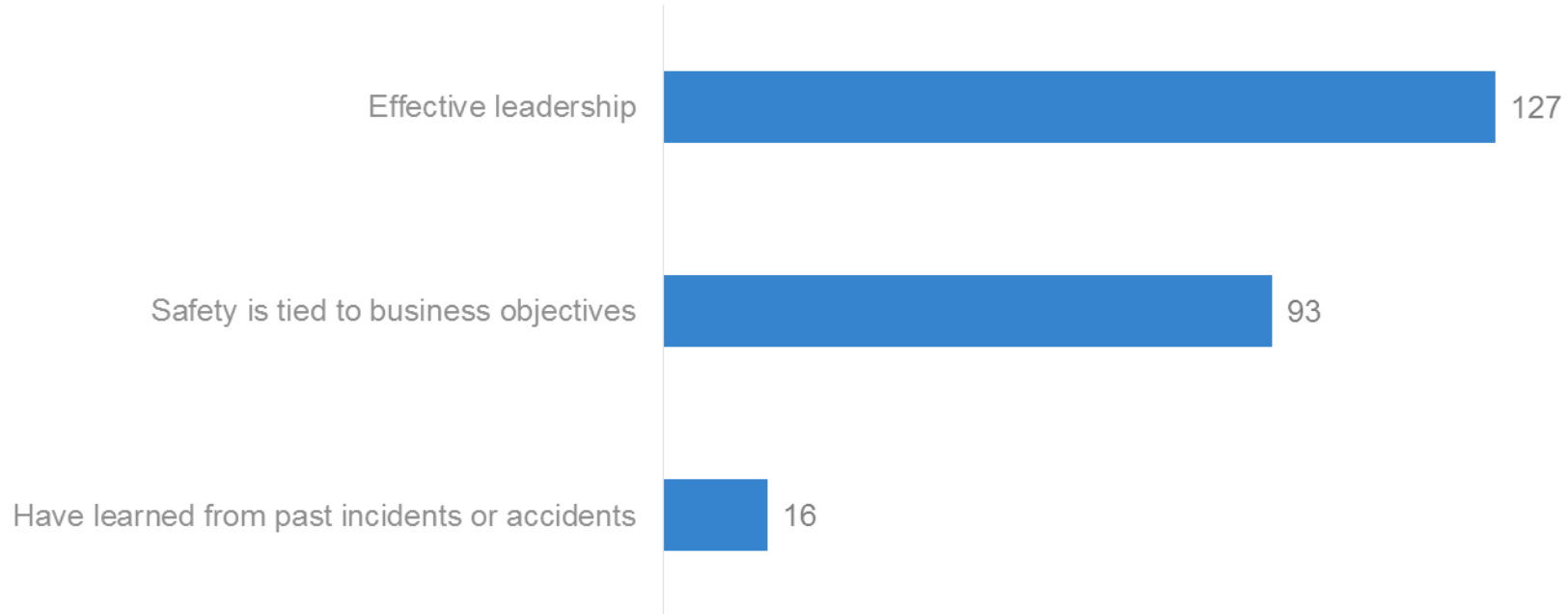

Main reason why members believe Organisations succeed:



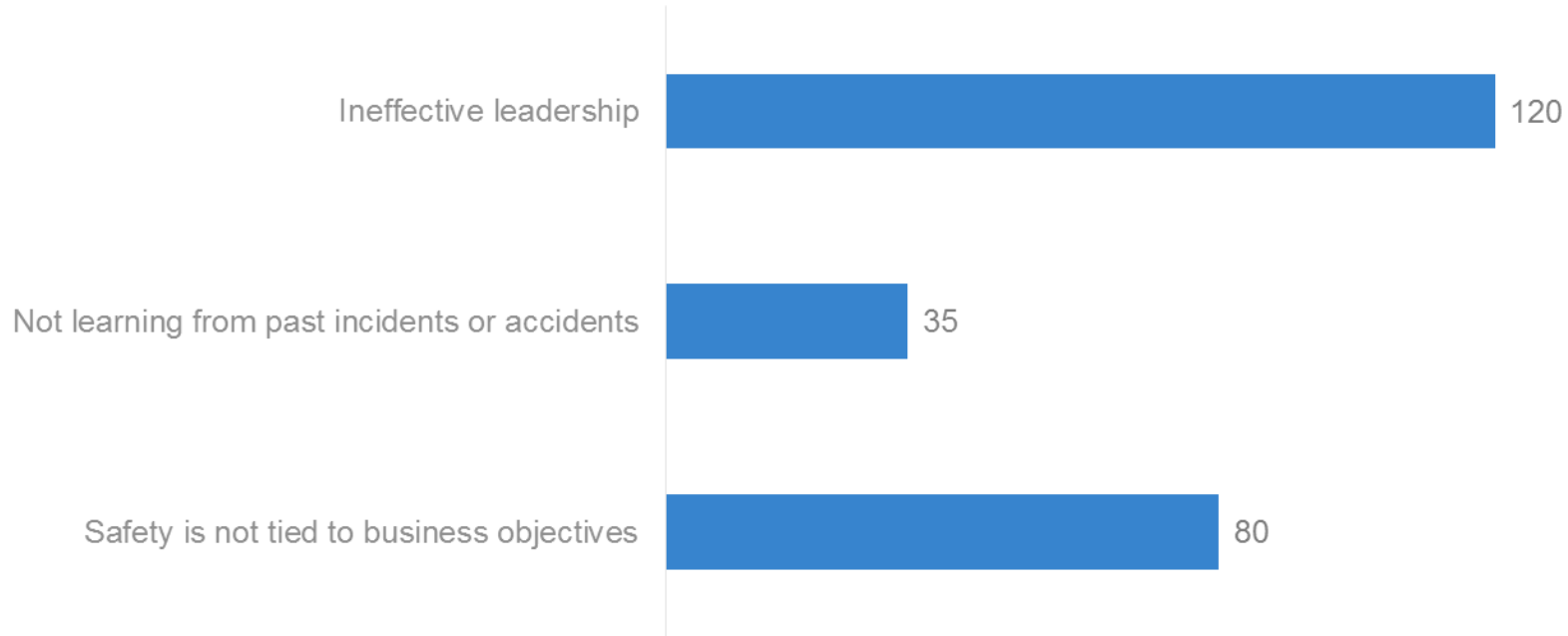
